After 6 months

.50 below full rate

After 12 months

Full rate

The new hire schedule hourly rate above will not be implemented or utilized without agreement from the Union.

Should the Employer require training certificates for Barista employees due to brand standards or other reasons, the Employer agrees to implement premium pay as consistent with other MCO operations.

Health Care

Participant in the UNITE HERE National Health Care Plan effective June 1, 2023.

PARKING

The Company will continue to pay cost of parking for duration of this local wage supplement.

MEALS

The Company will provide \$13 per shift towards one meal to each employee for each shift worked. The Company will provide free water, fountain drinks, coffee, and tea to employees who are working. The Company will not provide bottled water or bottled beverages.

DUES

Union dues will be deducted weekly.
